DETAILS

- **Setup Time: 7:00 AM - 8:30 AM | Event Time: 9:00 AM – 5:00 PM.**
- Demonstrators are strongly encouraged to dress for the occasion – time period 1870s-1900 OR steampunk.
- The Artist Village will be held indoors. Demonstrators will be assigned a 10x10 area with 1 table (6 or 8 ft) and 2 chairs. Please contact us to arrange a larger space.
- Booth assignments are made at the discretion of the event organizer.
- Final details will be sent one week prior to event, no later than April 17, 2026.
- The Doc Holliday Festival will be held rain or shine.
- Demonstrators may sell only goods made by the artists themselves; no resale permitted.
- Food may be demonstrated in period specific manner but not sold to the public.
- **Absolutely NO firearms or weapons of any kind are to be fired during the event.**
- Each Demonstrator shall provide their own insurance needs.
